- Candidates have to apply with **TANCET 2017** score.
- Students have to take a print-out of the Application Form and carefully fill the details before submitting the Application Form. (Attach the necessary documents).
- Last date for submission of filled in Application Forms: 16th June 2017.
- The completed application form should be submitted to the MBA-MCA Section, Trust
 Office, Ethiraj College for Women (Autonomous) in person along with the
 registration fee of Rs. 600/- in the form of DD in favor of "Ethiraj College MBA A/C"
 payable at Chennai.
- The college is not responsible for the loss of application forms sent through post/courier.
- Students applying for MBA are required to enclose a "**Statement of Purpose**" along with the application form. It should outline your vision, career objectives, personality traits, strengths & weaknesses that you feel would influence your course of study & career, purpose of the programme applied for.
- The following documents must be submitted in original at the time of interview failing which admission may be refused.
 - 1. Admission Card
 - 2. Mark Sheets: 10th, 12th & UG Mark Sheets
 - 3. Transfer Certificate
 - 4. Conduct Certificate
 - 5. Community Certificate
 - 6. Medical Fitness Certificate
 - 7. TANCET score card
- Students seeking admission from other universities (or) recognized bodies should produce the following documents.
 - 1. Pass Certificate
