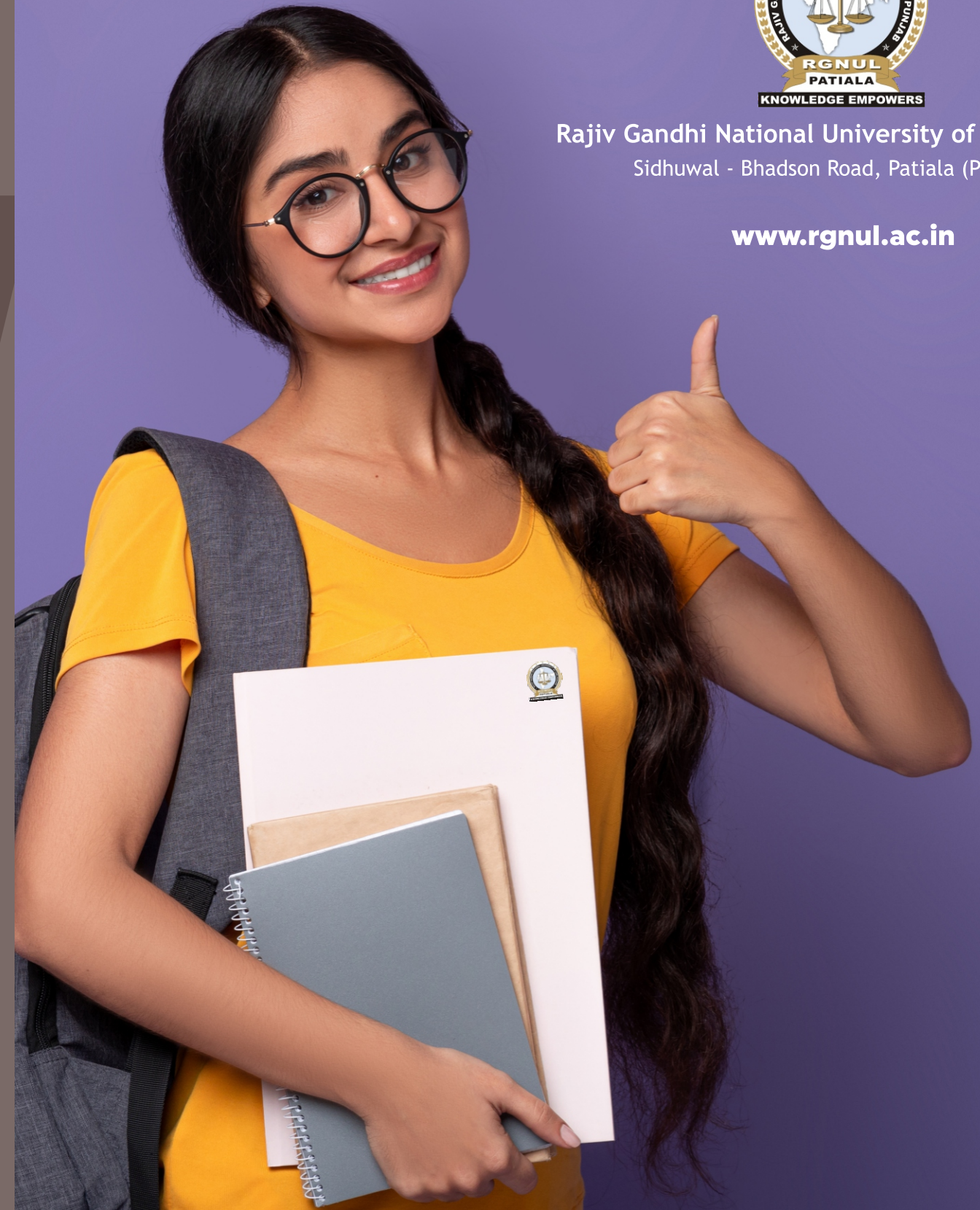

ABOUT RGNUL

Rajiv Gandhi National University of Law, Punjab (RGNUL) has been established by the State Legislature of Punjab by passing the Rajiv Gandhi National University of Law Punjab Act, 2006 (Punjab Act No. 12 of 2006). RGNUL campus is situated at Sidhuwal, Bhadson Road, Patiala (Punjab) which is about 70 km from Chandigarh.

The University acquired approval of the Bar Council of India (BCI) in August 2006. The University got registered with the University Grants Commission (UGC), New Delhi under Section 2(f) of the University Grants Commission Act, 1956 and also got recognition under Section 12-B of the UGC Act. RGNUL is a regular member of Association of Indian Universities (AIU), New Delhi and several other prestigious National and International institutions.

RGNUL is the first National Law University which has been awarded 'A' Grade by National Assessment and Accreditation Council (NAAC) after rigorous assessment based on various quality parameters. RGNUL has also been accorded Graded Autonomy under the UGC (Categorisation of Universities (only) for Grant of Graded Autonomy) Regulations, 2018. RGNUL received a major boost for its performance by being placed in the top 10 law universities in the NIRF rankings in 2018-19 and 2019-20. In Swachh Campus Rankings 2019 RGNUL has been adjudged at First Rank (Cleanest) in the Country among Government Residential Universities by MHRD.

TEACHING PEDAGOGY

The curriculum has been designed by the academicians and professionals, keeping in view the present dynamic environment. AT RGNUL, the students of MBA (Law) course will be taught the theoretical and practical aspects of the course by a blend of young, dynamic and experienced faculty members with suitable support of industry and eminent visiting professors. The students will be required to undertake the internship programs under the guidance of professionals and supervision of industrial experts for further knowledge enrichment and practical experience.

The teaching pedagogy will be an amalgamation of the following:

- Enhanced classroom teaching through Audio-visual sessions.
- Case Studies, Simulations and Role-plays.
- Assignment of Projects.
- Visit to the industrial enterprises to enhance their practical learning experience.
- Summer Internship Programs.
- Discussions with the leading experts at the national and international forum.

PLACEMENTS

The RGNUL Placement Cell aims to provide the students a planned transition from the University curriculum to a personal and professional setting in a students' area of interest. It also helps the students in guiding and planning their practical training programmes and placement. The Placement Cell is a duly constituted body comprising of both student and faculty members, primarily entrusted with the responsibility of facilitating and conducting recruitment process.

The following steps have been enumerated by the Placement Cell to streamline the recruitment process for the recruiter as well as students-

- Initial Communication with the Recruiter : The Placement Cell shall send invitations to recruiters along with the placement brochure and relevant information. Alternatively, an organisation may send description of potential career options to placementcell@rgnul.ac.in
- Pre-Placement Talks: We encourage Pre Placement Talks (PPT) by the recruiter with the interested candidates. The PPT provides an opportunity for students to learn more about the recruiter including its vision, career prospects and work culture among other things. However, the same is subject to discretion of the recruiter.
- Pre-Interview Screening Process: If the recruiter deems appropriate, a Pre interview Screening Process may be conducted prior to the final interview. The process may include group discussions, telephonic or skype interviews, written questionnaires or any other process that the recruiter considers necessary.
- Final Interview: Following the PPT and the Pre-Interview Screening Process, the recruiter is required to submit a list of candidates. The recruiter may also formulate a waitlist of students who may be interviewed if the selected applicant is unavailable for the interview.
- Intimation of Offers: The recruiter is required to intimate offer(s) made to the students solely through the Placement Cell. If the recruiter deems appropriate, a waitlist may be disclosed along with the final offers.

ADMISSIONS

Eligibility

A graduate of any discipline from a recognized university/institute, with a minimum of 55% marks (50% in case of SC/ST candidates) in the aggregate of all years of the respective course.

PROGRAMME FEE

Semester-I	Rs. 1,50,000
Semester-II	Rs. 90,000
Semester-III	Rs. 1,52,500
Semester-IV	Rs 1,07,500

Note: The selection of the candidates for admission to MBA(LAW) programme is a two-step process. In the first step, the candidates are shortlisted from among the candidates who have applied to the programme and submitted the application fee and those who satisfy the eligibility criteria. In the second step, the Group Discussion and Personal Interview Rounds shall be conducted. The final selection shall be done on the basis of the composite factors such as previous academic records and performance in the group discussion and personal interview of the candidates.
