MAH-MBA/MMS CET 2023 for A.Y. 2023-24

RE-EXAMINATION OF CANDIDATES WHO COULD NOT COMPLETE MAH-MBA/MMS CET 2023 DUE TO TECHNICAL ISSUES WITHIN MANDATORY EXAMINATION TIME AND WISH TO REAPPEAR AND OF THOSE CANDIDATES WHO GOT EXAMINATION TIME OF 180 MINUTES INSTEAD OF MANDATORY 150 MINUTES.

MAH-MBA/MMS CET 2023 for A.Y. 2023-24 was conducted on 25th & 26th March 2023 at 191 centres in Maharashtra and some other states as per the schedule declared on CET Cell website. On account of complaints received by the CET Cell about some candidates getting less than mandatory examination time due to various technical issues during the above said examination and also some candidates getting 180minutes instead of mandatory 150 minutes in the said examination , the CET Cell instituted an Enquiry Committee to look into all such complaints about the examination . On the basis of the Enquiry Committee Report, the CET Cell has decided to hold Re-Examination of

1. Candidates who faced technical issues/ glitches within mandatory examination time and who wish to reappear for the examination. Consent for Re-Examination is made available in their login.

And

2. Candidates who got examination time of 180 minutes instead of mandatory 150 minutes.

It may be noted that the earlier examination of such candidates <u>stands cancelled</u>. The list of these candidates is separately published on this website. These candidates will not be required to apply again.

The Re-Examination for both 1) and 2) above is scheduled on Sunday, 30/04/2023 from 9 am to 11 30 am. The CET result of all these candidates will be declared on the basis of the Re Examination only.

The application form for the Re-Examination is made available from 06/04/2023 up to 14/04/2023 to these candidates at https://cetcell.mahacet.org.

The above mentioned candidates will also be intimated through their registered e-mail and SMS on their registered cell phone number. Please note that it will be the responsibility of the eligible candidates to print their admit card and appear for the examination at the centre as per the time and schedule mentioned in their Admit Card.
