

Frequently Asked Question for PGMAC-2020 2nd Round Counselling (Medical)

Q. No. 1: *Who are eligible for 2nd Round Counselling?*

Ans:

- Those candidates who have not duly filled the online application earlier, to become eligible for 2nd round he has to duly fill the online application as per schedule mentioned in the Adv. No. – BCECEB (PGMAC)-2020/17 Dated: 06.08.2020 uploaded on Board's website.
- Eligible and Qualified candidate of round 1, due to any reason could not done choice filling process.
- Eligible and Qualified candidate of round 1, due to any reason could not fill their online application form completely & also not made payment.
- Eligible and Qualified candidate of round 1, allotted in round 1, document successfully verified, admitted against allotted seat by concerned participating institute and want to resign from allotted & admitted seat.
- Registered and filled the choices but seat not allotted in 1st round of counselling.
- Those candidates who were allotted a seat but due to any reason discrepancies generated in 1st round of counselling.
- Those eligible and qualified candidates who have duly fill the online application vide Adv. No.–BCECEB (PGMAC)-2020/17 Dated: 06.08.2020 uploaded on Board's website.
- The candidate who were allotted a seat in round 1 but, did not done online reporting i.e. fail to upload documents or required fee payment.

Note: Above points for candidate, they must have to give their willingness for attending 2nd round of counselling and have to fill fresh choices as per programme given in Adv. No. – BCECEB (PGMAC)-2020/17 Dated: 06.08.2020 uploaded on Board's website.

Q. No. 2: *I have resigned from 1st round allotted and admitted seat, now want to attend 2nd round of counselling, what will happened to my paid fee?*

Ans: Your paid fee will be forfeited.

Q. No. 3: *If I have resign from 1st round allotted & admitted seat, want to attend 2nd round of counselling, what will happen to my 1st round allotted seat on which I was admitted?*

Ans: If you have resigned from 1st round allotted and admitted seat and want to attend 2nd round of counselling then, your 1st round allotted and admitted seat will be cancelled and will not be allotted again the same seat in the same institution in the 2nd round of counseling.

Q. No. 4: *I have resigned from 1st round allotted and admitted seat, now want to attend 2nd round of counselling, what is the process for attending 2nd round counselling?*

Ans: If you have resigned from allotted and admitted seat then, you must have to give your willingness for attending 2nd round counselling and have to fill fresh choices as per programme given in Adv. No.- BCECEB(PGMAC)-2020/17 Dated : 06.08.2020 uploaded

on Board's website. Your paid fee will be forfeited & your 1st round allotted and admitted seat will be cancelled and will not be allotted again the same seat in the same institution in the 2nd round of counselling.

Q. No. 5: *I have registered in round 1, filled the choices, but not allotted any seat in 1st round?*

Ans: You must have to give your willingness for attending 2nd round of counselling and have to fill fresh choices as per programme given in Adv. No.- BCECEB(PGMAC)-2020/17 Dated: 06.08.2020 uploaded on Board's website.

Q. No. 6: *I have allotted a seat in round 1 but due to any reason unable to do online reporting?*

Ans: You must have to give your willingness for attending 2nd round of counselling and have to fill fresh choices as per programme given in Adv. No.- BCECEB(PGMAC)-2020/17 Dated: 06.08.2020 uploaded on Board's website.

Q. No. 7: *Who are not eligible for 2nd Round Counselling?*

Ans: Registered candidate, who filled up choices in Round 1 and allotted and admitted by getting document duly verified and did not given willingness as yes as well as do not resign from 1st round allotted and admitted seat.

Q. No. 8: *What are the guidelines for fresh choice filling before Second Round of online allotment process?*

Ans: Please go through the Adv. No. – BCECEB (PGMAC)-2020/17 Dated: 06.08.2020 uploaded on Board's website.

Q. No. 9: *Can I edit my choices during the time period of fresh choice filling?*

Ans: Yes, you can edit, add or delete your choices during the time period of choice filling before you lock your choices.

Q. No. 10: *I have not locked my choices before the schedule time on last date of locking choices, what will happen to my choices?*

Ans: The choices submitted and saved by you will be locked by the system at fixed time of last date/ date of choice locking as mentioned in Counseling Schedule, automatically.

Q. No. 11: *If the willingness of upgradation for round 2 is "Yes" and opt to participate in 2nd round of counseling whether my allotted and admitted seat (of first round) will be cancelled?*

Ans: It is mandatory to fill fresh choices during the choice filling as per programme given in Adv. No.- BCECEB(PGMAC)-2020/17 Dated: 06.08.2020 uploaded on Board's website and your previous filled choices of 1st round will become null & void. You must include the 1st round allotted and admitted seat in your choices filled for 2nd round at the time of choice filling at appropriate place otherwise, you lose the allotted seat of 1st round counselling. If in 2nd round seat allotment process you have allotted a seat of upper choices from the earlier allotted seat, then the 1st round allotted seat will be vacated and will be allotted to another candidate on the basis a merit-cum-choice. If the choices above of your previous allotted seat is not allotted, then your previous allotted seat will retained.

Q. No. 12: *Who are required to upload Undertaking for serve for further period of at least 2 year in Remote/Difficult area (Annexure-2 of updated revised prospectus of PGMAC-2020)?*

Ans: The candidate who have been allotted diploma remote seat, have to upload undertaking to serve for further period at least 2 year in remote or difficult area after acquiring the PG Diploma certificate as Annexure-2 of uploaded document in revised PGMAC-2020 prospectus. The Undertaking have to upload at the time of document uploading for document verification of 2nd round counselling.

Q. No. 13: *During the time of choice filling for 2nd round, should i exercise the choices according to seat matrix of 2nd round as uploaded on board's website?*

Ans: During the time of choice filling for 2nd round, you must exercise maximum no. of choices as shown in the choice list because during the seat allotment process new vacancies can be created.

Q. No. 14: *I have served as medical officer in Remote/Difficult area but due to some reason I have not claimed the benefit for medical officer served in Remote/Difficult area during submission of online application form for 1st round?*

Ans: If you have not claimed the benefit for medical officer served in Remote/Difficult area during submission of online application form for 1st round then you can edit your remote related data as per programme given in Adv. No. – BCECEB (PGMAC)-2020/17 Dated : 06.08.2020 uploaded on Board's website and must have to upload the work experience certificate as per criteria given in prospectus.
