ADVANCED RESEARCH METHODS

Course No. : SL 702

No. of credits: 4

This course focuses on the diversity of methodological strategies adopted in sociological research, depending on the 'problem definition' and theoretical perspective adopted. It begins with methodological foundations given by classical sociology and moves on to incorporate the changing needs of the discipline. It also draws on methodological innovations made in certain studies to resolve specific research issues. The importance of review of literature in the research area is emphasised for identifying 'gaps' in research to enable the researcher to identify 'significant' problems for research. For most part, the course is organised as a seminar course and requires each student to make two presentations involving discussion and evaluation of methodological strategies adopted in specific studies in diverse research areas.
