PREFACE

CAM-2020 is being conducted by Rajasthan Technical University (RTU) Kota, Rajasthan. The information brochure is helpful for the candidates seeking admission in the first year of Postgraduate Programs leading to Master's degree in Technology/ Architecture in Government aided and private unaided technical institutions of Rajasthan (affiliated to Rajasthan Technical University, Kota (Raj.) and Bikaner Technical University, Bikaner (Raj.)) through Centralized Admission for M. Tech./ M. Arch. (CAM- 2020). There will be no direct or spot admission by the participating institutions except through CAM-2020.

This Brochure contains eligibility conditions, admission procedure, and instructions for the candidates seeking admission to various M.Tech/ M.Arch programs offered by the **affiliated Engineering Colleges and University Departments of Rajasthan Technical University (RTU) Kota (Raj.) and Constituent/ affiliated Engineering Colleges of BTU, Bikaner (Raj.)**. Admissions would be made through the Centralized Admission process for M.Tech/ M.Arch for the academic year 2020-21. Candidates should carefully read this brochure before applying in CAM – 2020.

IMPORTANT UNDERSTANDING/ UNDERTAKING BY THE CANDIDATE

“Candidate must ensure the following important understanding/
undertaking before applying for CAM-2020”

They must read all the guidelines (information brochure), eligibility conditions for respective programs of CAM-2020.

1. They are aware of and abide by all eligibility criteria as mentioned in the information brochure and ensure that they fulfill all such conditions for taking admission in M. Tech./ M.Arch. program.
2. They undertake that they shall provide only authentic information and the entire document uploaded/ provided are self-attested. In case any information given by them is found incorrect at any point in time, their admission/candidature will automatically stand CANCELLED without any further reference and they will be liable for all the consequences such as cancellation of registration and forfeiture of registration fee followed by suitable legal action.
3. They are aware that after submitting the application form, they would not be able to change any information at any stage.
4. They also understand that they have the credit card/debit card/ net banking/payment gateway facility to pay the registration fees.
5. They shall provide their authentic mobile number and email id to CAM-2020. All the correspondence from CAM-2020 will be directed on this mobile number and email id.
6. They also understand that any grievance or complaint shall not be entertained after taking admission in the respective course.

1. About Rajasthan Technical University

Rajasthan Technical University (RTU) is located in Kota in the state of Rajasthan. It was established in 2006 by the Government of Rajasthan to enhance technical education across the state. The university is located on the bank of river Chambal and adjacent to Rawatbhata Road. It is about 14 km from Kota Railway Station and 10 km from Kota Bus Stand.

The Hon'ble Governor of Rajasthan His Excellency Shri Kalraj Mishra is the Chancellor, and Prof. R. A. Gupta is the Vice-Chancellor of the Rajasthan Technical University (RTU).

Rajasthan Technical University aims to provide quality technical education to help Rajasthan in its technical development and boost the technical environment in the country. The Rajasthan Technical University offers almost all the disciplines related to technical education including Bachelor of Technology, Master of Technology, Doctor of Philosophy, Master of Business Administration, Master of Computer Applications, and Bachelor of Hotel Management and Catering Technology.

The Rajasthan Technical University currently affiliates about 68 Engineering Colleges, 03 BArch, 16 MCA Colleges, 39 MBA Colleges, 31 MTech Colleges, 01 MArch, and 01 Hotel Management and Catering Institute. More than 1.5 lakh students study in the various institutes affiliated to the University.

Thousands of students graduate from the University every year and many attain post-graduation. The University is making steady progress in developing and providing the best technical environment for education and will continue to serve the nation in the coming years.

2. List of Available M. Tech. programs in various affiliated college and University departments

The list of the available MTech. programs and concerned affiliated colleges for the session 2020-21 are mentioned in **Seat Matrix** on the CAM-2020 website.

3. College fee Structure

As per the directions of the State Level Fee Committee, the interim fee structure for Engineering courses for the session 2020-21 is as mentioned in the college fee structure on the CAM website. Further, it may be noted that the directions from the state level fee committee or by the state government will be applicable for the session 2020-21 and afterward. The candidates shall be required to pay the fee as prescribed by the Committee.

4. Important Dates and Tentative Schedule

The tentative schedule of all activity for the admissions through CAM 2020 is mentioned in the **Tentative Schedule** on the CAM website.

5. Eligibility Criteria for Admission

Admissions for the session 2020-21 will be based on valid and eligible GATE Score of the year 2018-2020 preferably. **However, candidates without GATE score but possessing B.E./B.Tech./B.Arch degree or equivalent (As mentioned in Table-1) can also apply.** It is important to mention here that the scholarship offered in M.Tech./M.Arch. for GATE qualified candidates shall be as per AICTE norms which is 12400/- per month for 24 months. The office of CAM-2020, Rajasthan Technical University shall not be liable in any way for the release or sanction or grant of scholarship/stipend.

Candidates appearing in qualifying degree examinations in the academic session 2019- 20 and possessing valid GATE score card need to submit the marks sheet of qualifying degree examination at the time of reporting to the allotted institute positively, failing which their candidature shall be canceled.

A candidate must ensure their eligibility for admission in various M.Tech./M.Arch. programs in the constituent institutions, affiliated institutions, and University Departments before filling up the application form of CAM-2020.

If a non-eligible candidate is admitted due to any reason, then the admission of such a candidate will be canceled even at the later stage.

Minimum Qualification Required

Candidates seeking admission for M.Tech./ M.Arch. programs must ensure the following minimum qualification.

(i) A candidate must hold B.E./B.Tech. degree in appropriate discipline mentioned in Table-1 from RTU or any other recognized University/ Institution or any other examinations recognized as equivalent thereto by the competent authority.

(ii) Candidate must have a minimum of 50% (6.25 CGPA on 10 points scale and equivalent) marks in the qualifying degree examination (45% or 5.75 CGPA on 10 points scale of relaxation is admissible for SC/ST candidates) (as per AICTE APH 2020-21). If a recognized university has an approved conversion formula of CGPA into a percentage, then it will be made applicable subject to producing the certificate of conversion from the concerned University. Otherwise AICTE approved conversion formula will be used i.e. Equivalent CGPA = (Percentage/10) + 0.75.

(iii) Candidates having B.Arch. degree and seeking admission to M. Arch/M. Plan programs should possess 50% (5.75 CGPA on 10 points scale and equivalent) and 45% (5.25 CGPA on 10 points scale and equivalent) in case of SC/ST, as per the requirement of COA.

(iv) Candidates with qualifications obtained through examinations conducted by professional societies recognized by MHRD/UGC/AIU/UPSC/AICTE (e.g. AMIE

by Institute of Engineers (India); AMICE by Institute of Civil Engineers (India); IEE) as equivalent to B.E./B.TECH.

(v) Candidates having M.Sc./MCA seeking admission to certain M.Tech. programs should possess a valid and qualified GATE score of the relevant branch. The equivalency of any degree for admission to any program will be decided by University.

The eligibility criteria given in the following table are minimum and merely possessing the same does not qualify the eligibility for admissions. University may prescribe any other requirements over and above these conditions.

6. Reservation of Seats

As prescribed by the Government of Rajasthan (except in case of Private Institutions and 50% seats in the self-finance course of the Govt. institutions) the reservation of seats will be made subject to the prevalent statutory provisions of the State of Rajasthan i.e. 16% for SC candidates, 12% for ST candidates, 21% for candidates belonging to non-creamy layer* OBC category, 10% for Economical weaker section (EWS) candidates¹ and 5% for candidates belonging to non-creamy layer MBC category** as per the state government order dated 22/02/2019. Also, as per the state government order no. F1(6)/Tech.Edu./1999 Jaipur Dated 15-09-2011, the 45% seats of prescribed 12% ST quota will be reserved for TSP in all institutions where ST reservation is available. The candidates who belong to notified areas of eight districts namely Banswara, Dungarpur, Pratapgarh, Udaipur, Sirohi, Rajasmand, Pali, and Chittorgarh (i.e. districts in the tribal region) come under ST reservation will be eligible under this quota. Provision will also be made for horizontal reservation of 5% for candidates belonging to Persons with Disability (PwD), 25% for Women category, and 3% for dependents of Defence Killed/Ex-servicemen / Gallantry award winners.

Priority for the category of Defence Persons will be as follows:

Reservation of girls in this category:- 50% of the reserved seats in this category are earmarked for the girls.

As per the Order/File No 3-4/2017-NER of MHRD dated 15/10/2019 additional 5% of intake capacity per Course/ branch (over and above sanctioned seats) will be reserved for Kashmiri Pandits/Kashmiri Hindu Families (Non-migrants) and Kashmiri migrants. The requirement of a Domicile Certificate is waived off for Kashmiri migrants only but Kashmiri Pandits /Kashmiri Hindu Families (Non-migrants) living in Kashmiri Valley need to produce Domicile Certificate.

EWS Category: - In addition to the above reservation, a maximum of 10% of sanctioned intake per course shall be available for the Economical weaker section (EWS). These EWS seats shall be supernumerary in nature.

Definition of SC/ ST/ Non-creamy layer OBC/ Non-creamy layer SBC

Category:

The benefit of reservation under SC/ST/Non-creamy layer OBC/Non-creamy layer SBC and EWS category shall be available only to the candidates of the castes as notified under Presidential order for the State of Rajasthan, for which, the certificate should be issued by the competent authority as mentioned in the CAM-2020 website. However, for claiming the benefit in non-creamy layer OBC/non-creamy layer EWS and SBC category, the candidate will also have to furnish an undertaking in the prescribed Performa as given on the CAM-2020 website.

It is further clarified that candidates belonging to the creamy layer OBC/ creamy layer SBC category are not entitled to reservation benefits and shall be treated in the General category. Therefore, creamy layer OBC/creamy layer MBC and EWS candidates should fill the General category in their application form.

The above-mentioned provisions for the reservation are as per the present norms. These provisions may be changed/alterd/modified as per the directions of the Government of Rajasthan/ Hon'ble Court/ Competent authority and the same shall be binding on all the concerned parties.

7. Medical Fitness

A candidate desirous of admission to various Master's degree programs will be required to submit a Medical Fitness Certificate at the time of reporting in the allotted institution in the prescribed form certified by a Medical Officer of the Government of Rajasthan or a Registered Medical Practitioner.

8. Registration Fee

A candidate is required to pay the **registration fee of CAM-2020, which is Rs. 3000/- (Rs. 1500/- for SC/ST category)** and can be submitted online through the Billdesk gateway facility with the help of credit card/debit card/net banking/other online payment gateways. Gateway charges, as applicable, shall be paid by the candidate. In the payment mode through Billdesk, a candidate is advised to take note of the transaction ID and keep the receipt/transaction Id details safe for future use.

To activate the online application form for entering the required details, the candidate must enter his/her transaction ID in the appropriate column of the application form. The online application form will not authorize entries without his/her transaction ID.

Registration fee is non-refundable, non-transferable, and non-adjustable anywhere, in any case.

9. Centralized Admission for M.Tech./ M.Arch. (CAM 2020)

Candidates seeking admission to Master of Technology (M. Tech.) programs in affiliated institutes/University departments of Rajasthan Technical University shall participate in the CAM-2020. The application form is to be submitted online on

<http://www.rtu.ac.in/RTU/cam2020>

The candidate must fill all the details carefully as required in the online application form.

9.1 Admission Process

The notification for CAM-2020 will be notified in Newspaper(s)/ CAM-2020 website as per the tentative schedule. All candidates (whether having a valid GATE score or not having a valid GATE score but, fulfilling the eligible qualification as given above) are required to complete all the stages of admission process given below. The admission process is divided into the following stages:

- 9.1.1 Stage I: Online registration and fee payment,
- 9.1.2 Stage II: Filling of the application form,
- 9.1.3 Stage III: Uploading the documents, online choice filling and locking,
- 9.1.4 Stage IV: Seat allotment,
- 9.1.5 Stage V: Physical reporting and admission in the allotted institutes.

9.1.1 Stage I: Online registration and fee payment

A candidate is required to register online on CAM-2020 website by providing the following details: -

Name of the candidate, Mother's Name, Father's Name, Date of birth, Mobile no., email id and submit to register themselves for the CAM-2020. A challan number will be generated which is used for the application form fee payment. The candidate must note down the challan number and keep it safe and confidential.

The challan number of the first transaction (registration fee) will be the default login ID. Candidates are advised not to disclose their login ID and password for the CAM-2020 web portal to anybody else. CAM-2020 will not

be responsible for any loss or damage or harm caused due to the candidate disclosing his/her login ID/password to any other person/institute/agency/society. The next step is to pay the application form fees of CAM-2020, which is Rs. 3000/- (Rs. 1500/- for SC/ST category). Fees can be submitted online through the Billdesk gateway facility, where a candidate is required to fill the online details of their credit card/debit card/net banking/other online payment gateway details. A candidate is required to pay any other admissible charges as per the requirement of the online payment gateway, as applicable. A transaction ID will be generated after the payment. The online application form will not accept entries without the transaction ID. The candidate must note down the Transaction Number and keep it safely with him/her. The transaction number is required in case of Transaction failure. Generally, it takes about 48 hours to sort out matters related to transaction failure. CAM-2020 will be able to sort out the matters related to Transaction failure only if the amount is deposited /credited to the partner gateway agency.

In case there is a refund due to the candidate because of online transaction failure/ Double or multiple payments of the registration fee, the same shall be settled after the completion of the admission process in CAM-2020. **All the refunds, after verification, shall be credited/ refunded in the same account from which the payment is initially received.** In no case, the Office of CAM-2020 shall entertain the request to transfer/ Refund/ Credit the refund amount in a bank account other than the one from which it was initially received. **Candidates are therefore advised to make payments from their own Bank account/ Debit card/ Credit card/UPI/payment Gateway.** CAM-2020 shall in no way be liable for circumstances arising out of candidate making payment from other person's Bank account/ Debit card/ Credit card/UPI/payment Gateway.

9.1.2 Stage II: Filling of application form

To activate the online application form for entering the required details, the candidate must enter his/her transaction ID in the appropriate field of the application form. Then the candidate will be allowed to fill the application form

with their personal and academic details as per the requirements. In this section of the application form, a candidate is required to fill their: -

Personal details, Address for correspondence, Educational qualifications details, GATE score details, etc.

The entries of the online application form must be filled as required. The changes (if required) will be allowed in the online application form before final submission i.e. before pressing the “Submit” button on the web portal. The Web page will not accept any changes after the final submission of the online application form i.e. after pressing the “Submit” button on the web portal. Therefore, the candidates are advised to click the “Submit” button only if he/she is sure that the data entered in the online application form is correct and no further editing is required.

If the information submitted by any candidate is found to be fraudulent, incorrect or untrue, the seat allotted (if any), shall stand canceled and his/ her fees deposited shall be forfeited and he/she will also be liable for legal action. CAM-2020 will not be responsible for any consequence arising out of non-acceptance of any correction/ addition/ deletion of Data of the application form after clicking the “Submit” button.

Candidates are advised to take the printout of application form after final submission, which will be generated by the web portal and attach the self-attested photocopies of all the relevant documents. The application form with relevant documents will be required at reporting institutes. A reporting institute is where the admission has been given to the candidate. The candidate is also advised to bring their originals documents at the time of reporting.

The hardcopy of the application form is not required to be submitted to the CAM-2020 office or RTU Kota.

9.1.3 Stage III: Uploading the documents, online choice filling and locking,

The eligible candidates, who have registered, made the payment of application/registration fees and have filled the application form successfully will be required to upload the following documents (Self-attested) as scanned images preferably in .jpg format as follows;

- i. Photograph in jpg format (image size Maximum up to 50 KB)
- ii. Signature in jpg format (image size Maximum up to 50 KB),
- iii. Valid GATE scorecard, if qualified (image size Maximum up to 300 KB),
- iv. Mark sheet of B.E./B.Tech. or mark sheet of last qualifying examination (300 KB)

Only the eligible candidates, as per CAM- 2020 rules will be considered for seat allotment and subsequent admission. In this stage, all the valid registered candidates are required to exercise their choices of programs and institutes in order of their preference for these programs / Institutes.

The choice filling procedure is as follows;

- i. To participate in the choice filling process, the candidate has to login for the choice filling option.
- ii. The procedure for exercising choices and seeking pertinent information would be guided through appropriate messages and tabs on the relevant webpage of the CAM-2020 website.
- iii. Available seat information relating to institutions, departments, and the program will be displayed in seat matrix on CAM-2020 website. It would be the responsibility of the candidate to ensure that he/she fulfills all the necessary eligibility conditions of the M.Tech./ M.Arch program before registering/choice filling for the concerned program.
- iv. Candidates can fill in as many numbers of choices in the order of preference, as they wish, from the list of available programs. There is no maximum limit for filling the choices. **It is advised that the candidates should fill the maximum number of choices to help avoid the exhaust of choices situation. Candidates are also advised to fill the choices with utmost care as they won't be allowed to change/alter/modify their choices in second round (Upward movement).**
- iv. Candidates are permitted, if they so desire, to change/alter/modify or re-order their choices, delete earlier choices and add new choices any number of times until they lock their final choices. Choices should be

positively locked before the last date otherwise choices will be automatically locked after the last date.

9.1.4 Stage IV: Seat allotment

As per the tentative schedule, the choices submitted by the candidates will be processed centrally and seats will be allotted in the order of merit (as per the rules of merit) based on the locked choices. **Valid GATE score would be given higher priority during all the stages of counseling and merit declaration in CAM-2020.**

The allotment of institute and specialization to the candidate will be carried out through the computer software by strictly following the order of merit, seats available, and the order of options filled by the candidate. The allotment result will be available on the CAM-2020 website as per the tentative schedule.

Seat Allotment Procedure

The seat allotment is divided into various rounds as per the requirement and convenience of the candidates into various M.Tech. /M.Arch. programs.

First round:

- i. In this round, seats will be allotted to all registered candidates based on their choices and merit list criteria.
- ii. All allotted candidates are required to report to the allotted institute for document verification and college fee submission. A candidate who reports at the allotted institute and completes the formalities to join the allotted institute shall only be eligible to opt for the second round (Upward movement).
- iii. A candidate who has been allotted a seat (Allotted Candidate) needs to give his/her consent online as per schedule for participating in the second round (upward movement).
- iv. **A candidate who does not report (non-reported candidate) to the allotted institute as per the schedule, his/her registration would be deemed canceled.** However, he/she may register again as a new candidate in the third (Spot) round with payment of registration fees.

- v. If a candidate wishes to surrender his/her occupied seat, he/she needs to submit the seat surrender form which is available on the CAM website and also required to submit his/her consent online on the link (**seat surrender option**) on CAM-2020 website. After completing the seat surrender formalities, his/her registration will be deemed canceled. However, he/she may register again as a new candidate in the third (Spot) round with payment of registration fees.
- vi. If a candidate has not been allotted any seat due to exhaust of choices (Choice-exhausted candidates), he/she will be considered automatically for the second round of upward movement.
- vii. If a candidate fails to produce a valid GATE score and eligibility, his/her allotment and candidature will be canceled and he/she will not be allowed to occupy any seat. However, with valid eligibility, he/she may register as a new candidate in the third round.

Second round:

- i. This is an upward movement round, where a candidate is essentially required to submit his/her consent **ONLINE** for the upward movement against the allotted seat in the first round. **The candidates who do not report in the allotted institute after allotment of seat shall be ineligible for “Upward movement”.**
- ii. All the candidates who have reported in the allotted institute in the first round of allotment by following the due process for reporting and give their consent online on the CAM-2020 website for Upward movement, will be eligible for participating in the second round (Upward movement).
- iii. **Kindly note that the candidate is not allowed to change/alter/modify their options or choices in the Option/choice form when they apply for the “Upward movement”.**
- iv. After his/her consent for the upward movement, his/her earlier allotted seat would be available for allotment to subsequent candidates only if, a candidate has got his/her higher preference, otherwise his/her seat will remain the same. However, if a higher choice is allotted to a candidate in

the upward movement round (second round), he/she will have no claim over the allotment of the first round.

- v. After the second round (Upward movement) allotment, the candidates are required to report to the allotted institute for document verification and college fee submission.
- vi. A candidate who has not reported to the allotted institute as per the schedule, his/her allotment, and registration will be deemed canceled. However, He/she may register again as a new candidate in the third round (Spot round) with payment of registration fees.
- vii. Point no. v & vii of the First round will be applicable for surrender/ withdrawal and non-fulfillment of eligibility criteria in this round also.
- viii. If a candidate has not been allotted any seat due to exhaust of choices (choice-exhausted candidate) in the second round of upward movement, his/her registration would be deemed canceled. However, he/she may register again as a new candidate in the third (Spot) round with payment of registration fees. Candidates are advised to fill sufficient choices to help avoid the exhaust of choices situation.

Third round (Special round/ Spot round):

- i. This is the special round in which admission would be offered for vacant/ available seats.
- ii. The vacant seat matrix for the vacant seats will be displayed on the CAM-2020 website.
- iii. Any interested/new candidate may register for this round by paying Rs. 3000/- (Rs. 1500/- for SC/ST) as registration fee.
- iv. All allotted candidates are required to report to the allotted institute for document verification and college fee submission.
- v. The registration/ application fee will not be refunded back, in case the candidate does not report to the allotted Institute.
- vi. **All the candidates who are not-reported (i.e. the candidate does not join the allotted institute after allotment) at the end of first/second round or Choice-exhausted candidates (i.e. the candidates are not allotted any choice/option due to choice exhausted) at the end of the**

second round of upward movement, will have to register again in the third (Spot) round as a new candidate by paying the registration fee again.

9.1.5 Stage V: Reporting & admission

- i. A candidate, who have been allotted seat shall be required to report at the allotted institute as per the tentative schedule.
- ii. Provisional seat allotment letter may be printed from the CAM-2020 website using their login details.
- iii. Candidate should paste their recent color photographs on the application form (the registration form) with one additional colored photograph with them.
- iv. Candidates are advised to carry two sets of self-attested photocopies along with original documents at the time of reporting to allotted institutions. The following documents shall be attached along with the latest color photograph identical to the photo uploaded with the online application. The order of relevant documents as per their applicability are:
 - (i) Provisional seat allotment letter,
 - (ii) Application form with a colored photograph,
 - (iii) Class X (High School) Board Certificate as proof of date of birth,
 - (iv) Mark sheet of Class XII,
 - (v) Consolidated Grade/ Mark sheet of qualifying degree,
 - (vi) Qualified and valid GATE scorecard, if any,
 - (vii) Certificate of category (OBC/SBC/SC/ST/EWS), if applicable, issued by the competent authority,
 - (viii) Undertaking by OBC/SBC in the required format, if applicable,
 - (ix) Certificate for Person with Disability (PWD), if applicable,
 - (x) Certificate for Ex-servicemen, if applicable,
 - (xi) Domicile certificate,

- (xii) Conversion certificate for converting CGPA to percentage from the recognized university in which you have passed your UG degree,
- (xiii) Migration certificate
- (xiv) KM category, if applicable.

The allotted institute will be responsible for checking the documents and other required certificates with originals. A candidate has to deposit only the course fee to their allotted institutes.

Information regarding hostel facilities can be obtained from the allotted institute. Once the checking with originals has been done, original certificates will be returned to the students.

The candidates need not submit their original documents to the allotted institutes, the originals are only required for verification purposes. The original documents may be required by the allotted institute again for University enrollment.

Note: Due to the situation arising out of the Covid-19 pandemic, following additional admission procedure for admitting the candidates in M.Tech./ M.Arch. courses will be followed. After the admission process as mentioned above is over, the participating institutes will be permitted to give admission to the eligible candidates against the vacant seats, strictly as per the declared schedule, in the following priority:

- (a) Registered and unallotted eligible candidates in CAM-2020
- (b) Any eligible candidate.

However, the institute will have to follow the guidelines issued by Coordinator, CAM/DAT-2020. The participating institute will be responsible for checking and verifying the eligibility of the candidate. CAM-2020 will not be, in any way, liable for the refusal of enrolling university for enrolling the candidate. The participating institute will ensure to deposit the registration fee of the candidates admitted at their level along with the list of candidates admitted and other desired details in the office of Coordinator, CAM-2020 strictly as per schedule.

10. Surrender & Withdrawal:

- i. If a candidate wishes to surrender his/her occupied seat, he/she needs to submit the seat surrender form to the last allotted institute, which is available on the CAM-2020 website and also required to submit his/her consent online on the link provided on CAM-2020 website. After completing the seat surrender formalities, his/her registration will be deemed canceled.
- ii. The institute should report the surrender of the candidate immediately so that the seat which has been surrendered by the candidate may be included in vacant seats for further allotment. CAM-2020 shall in no way be responsible/ liable for any left-out seats due to delay in reporting of the surrendered seats.
- iii. If a candidate surrenders his/her allotted seat on or before the specified date, he/she will get a refund from the allotted institute with the deductions of processing fee and administrative expenses. The Office of CAM-2020 shall in no way be party/ mediator/ liable for the refund of fee (if due) by the allotted institute.
- iv. A candidate, who starts attending the classes in their respective course, may take a withdrawal from their program. The refund will be as per AICTE provisions. The Office of CAM-2020 shall in no way be party/ mediator/ liable for the refund of fee (if due) by the allotted institute.

11. General Guidelines and Instructions

- i. Candidates are advised in their interest to secure updated information regarding the admission from the authorized web site of CAM-2020.
- ii. The non-receipt of communication to the candidate from Convener, CAM-2020, RTU, Kota, Rajasthan, will not be accepted as a ground for not participating in filling option form or non-reporting in the allotted institute on the scheduled time and date.
- iii. The admission of the candidate will be provisional till the eligibility/enrolment certificate is issued by the enrolling University. CAM-

2020 will not be, in any way, liable for the refusal of enrolling university for enrolling the candidate.

- iv. If for reasons to be recorded in writing, the Coordinator, CAM-2020 suspect that a particular candidate has obtained a certificate by misrepresenting or concealing the material facts, the matter will be referred to the competent authority. On receipt of the report, the Convener, CAM-2020 would take the final decision regarding the admission of the candidate and the admission will be treated as provisional during this period.
- v. Permission to participate in CAM-2020 shall not guarantee fulfilling eligibility criteria for admission and only the eligible candidates will be considered for admission as per norms.
- vi. All the candidates (who have obtained seat allotment letter) have to visit regularly the CAM-2020 website for the status/up-gradation of their allotted seat. They should take a printout of the letter indicating new allotment as available on the website if any. During reporting to the allotted institute for admission, candidates shall carry a printout of the latest allotment letter from the CAM-2020 website.
- vii. If any information (Personal as well as Eligibility) of the candidate has been found incorrect anytime, his/her candidature will be canceled and such candidate will not be considered for seat allotment in subsequent rounds.
- viii. The Office of CAM-2020 will not be responsible for any consequence arising out of non-acceptance of any correction/addition/deletion of any data after the final submission or printout thereof.
- ix. In case of any dispute arising out of the admission process at any stage up to the final allocation of the institution and/or program, the decision of

Rajasthan Technical University, Kota shall be final and binding. **The jurisdiction for legal disputes, if any, will be limited to Kota city only.**

- x. Classes will begin as per the guidelines received from the Government of Rajasthan/ All India Council for Technical Education (AICTE)/ Competent Authority in all the institutes. No separate instruction will be issued by RTU, Kota.
