
The students, who got allotted to CBIT into B.E./B.Tech. III-Semester through Convener, TSECET-2022 are hereby informed to note the following.

4. Tuition Fee Notice, as mentioned in the attached document.



## **TUITION FEE**

### **Notice for students seeking admission during 2022-23**

All the students who are joining B.E/B.Tech. course through ECET or EAMCET in Chaitanya Bharathi Institute of Technology (CBIT) in the block period 2019 to 2022 are hereby informed and put on notice that in terms of the common Order dated 29.04.2020 of the Hon'ble High Court of Telangana in Review Petitions in I.A. No. 2 of 2019 in W.P. No. 22564 of 2016 and in I.A. No. 4 of 2019 in W.P. No. 22595 of 2016, CBIT is entitled to claim before the TAFRC an annual fee structure for the students admitted in the block period 2016 to 19, an amount which will include the expenditure incurred by the Institute towards the actual amounts spent towards non-teaching staff salaries, the expenditure towards paying the teaching staff salaries in terms of the 7<sup>th</sup> Central Pay Commission guidelines and the expenditure towards increase in payment of installments due to increase in the gratuity limit payable to the staff and the consequent orders from the TAFRC are expected which are subject to challenge before the Courts of Law and that based on the same, tentatively the annual fee for the students admitted during the block period 2016 – 19 is Rs.1,62,377/- and further that the annual fee for the students admitted during the block period 2019 - 22 will have 15% to 18% increase over the annual fee of the previous block period and thereby the students admitted during block period 2019 – 22 will have to pay such increase in annual fee and the said annual fee is subject to the outcome of any petitions/appeals before the Courts of law. A student admitted in the 2<sup>nd</sup> year B.E/B.Tech. Course under lateral entry in the year 2022-23 is deemed to have been admitted in the 1<sup>st</sup> year of B.E/B.Tech. Course in the year 2021-22 for the purpose of categorising the block period in which the student is deemed to have been admitted for the purpose of fixation of annual fee and so on. Thereby the students admitted in regular course and under lateral entry in B.E/B.Tech courses in the academic year 2022-23 are put on notice that their annual fee is liable to be enhanced to Rs.1,86,733/- instead of Rs.1,34,000/- as fixed by TAFRC, based on the outcome of the petitions/appeals before the Courts of law.
