**Instructions for the candidates:**

01. The selection of the candidates is purely provisional and subject to verification of documents and valid objection/s, if any. Mere mention of the name of the candidate in the list will not confer any right to admission to him/her where inclusion of the name in the list is due to a bona-fied error and not on the basis of the prescribed merit.

02. The selected candidates will get the online fee submission link by login to their account registered on samarth portal for payment of one time admission fee. This does not **their include tuition fee** which will be decided separately by the competent authority of the University. Further the candidates are informed to complete admission formalities by or before **1<sup>st</sup> July, 2024 upto 11:50 PM**. After the admission process, the students have to report to the department along with the following.

- i. Admission Form with a valid fee submission receipt and the following original documents.
- ii. Marks certificates of qualifying examinations.
- iii. Character/ Provisional certificate in original.
- iv. Category certificate (if applicable) in original, issued by competent authority in Government of India format.
- v. Anti-ragging undertaking form appended with the required signatures

03. The candidates whose result of qualifying examinations are pending/awaited as on date must deposit their admission fees by or before the given time and can produce the certificates before the commencement of classes. If the candidate fails to fulfill the eligibility conditions his/her admission shall be cancelled.

04. Any candidate who fails to complete his/her admission formalities within the prescribed time will be considered subsequently in the waiting list subject to the availability of the seat and only after the last date of then current list is over. Such candidate has to make a representation to the admission committee for his/her consideration for admission, giving reasons for not completing his/her admission within the prescribed time. Such candidate has no right to claim admission once all the seats of his/her category are filled.
