5. If any candidate is found with false documents or unable to produce above mentioned documents, the admission will not be allowed and will be cancelled.
6. After the counselling and successful verification of the documents, the provisionally selected candidates may download the admission slip and make payment through SAMARTH portal. The **last date of the payment of Admission Fee online is on or before 9th July 2024 (Tuesday)**.
7. The classes will be commenced **from 12th July 2024 (Friday)**.
8. **Whereas, in case of any vacancy arise after the counseling for candidates** enlisted in the above mentioned lists, the **admission will be offered to the candidates on “Waiting” in the Merit List, if they appear for the counseling on the scheduled date and time**.
