NID DAT Mains result for B. Des has been released online. The result is available online at the official website - admissions.nid.edu. To check your results, you need to log in to the result portal using your email ID and date of birth. - The result re-check window is also OPEN.
- Candidates who are shortlisted for admission will have to submit campus preferences by May 23, 2024 (4 pm).
- Earlier, M.Des DAT Mains 2024 results were declared on April 30, 2024. NID DAT 2024 Prelims Result for M. Des was released on 16th February 2024.
- [NID DAT 2024](#) is conducted in two stages- NID DAT Prelims and NID DAT Mains. Final selection is going to be made based on the weightage released by the institute to be allocated to DAT Prelims and DAT Mains. [Check NID DAT 2024 Counselling](#)
- [NID DAT 2024](#) for DAT Prelims is conducted on 24th December 2023. NID DAT Mains exam consists of – Studio Test and Personal Interview round. On the basis of these scores, candidates are going to be eligible to take admission to [NID DAT Participating Colleges](#).

NID DAT 2024 Result Dates


For NID DAT, only candidates who qualify in the written test will be called for Studio Test and Personal Test. The result dates for both stages have been mentioned below:

How to Check NID DAT 2024 Result?

NID DAT 2024 Mains result will be released soon for M. Des. Based on NID DAT 2024 score, [NID Merit List](#) is prepared for shortlisted candidates who are invited for further rounds of screening called the studio test and personal interviews. The candidates can follow the below steps to check their results online.

- Go to the official website- admissions.nid.edu
- Click on the 'NID DAT 2024 Result' link
- Enter the roll no. and application number and click on submit.
- The result will appear on the screen
- The printout can be taken and kept for further reference.

Rechecking of NID DAT Prelims Result

Candidates who have requested for NID DAT Rechecking of the Prelims result 2024 must follow the rules :

- The fee for rechecking each paper of NID DAT is Rs.2000
- They must submit the answer booklet online at admission.nid.edu.
 - Rechecking will be restricted to
 - Whether all the answers have been marked

- Whether there is any mistake while adding the final marks.
- No other re-evaluation of the answer script will be done by the candidate as part of the examination carried out.
- The candidate who has qualified for the exam only are allowed to file for re-checking no other candidates, parents, or organisations are allowed.
- If an error is found while re-checking, marks will be added accordingly.
- If any error is found relating to the re-checking a mail will be sent to the candidate.
- The institution will not be responsible for any damage or loss of the candidates.

NID DAT Tie-Breaker Policy 2024

NID DAT tie-breaker depends on the merit list of the candidates. The following policy of Tie-Breaker is as follows:

- A higher rank will be assigned to the candidate who has obtained higher marks
- If this persists, then the higher rank candidate will be promoted to stage 1 of the NID DAT Test.
- If still undecided, a higher rank will be assigned to the candidate who has obtained higher marks in Stage 1 Design Aptitude Test Part B.
- If still undecided, a higher rank will be assigned to the candidate who has obtained higher marks in the Stage 1 Design Aptitude Test Part A.
- If this still continues, the candidate will be assigned a higher rank who has obtained higher marks in NID DAT Mains.

NID DAT 2024 Cut Off

NID DAT 2024 Cut Off is usually announced soon after the results are declared. The candidates who score over the cut off are considered eligible for the examination

NID DAT 2024 Counselling Procedure

National Institute of Design generally conducts counselling during the months of June and July offering admissions into Bachelor of Design (B.Des), GDPD and M.Des. Counselling of NID DAT is held after the three stages of the selection process are completed, Stage 1- Design Aptitude Test (DAT), Stage 2- Studio Test and Stage 3- Personal Interview. The entitlement to admission will not be guaranteed only on the basis of appearance in the entrance test or being on the rank list.

The results of NID DAT prelims is generally announced in the month of February or March every year. The shortlisted candidates are required to appear for the mains exam to be conducted in the month of April 2024. The final Merit List of NID DAT is usually released in the same month i.e. fourth week of May 2024. This is followed by the NID DAT counselling procedure which is held for selected candidates on a merit basis.

After online verification of documents, the shortlisted candidates in the rank list are allotted seats provisionally. To be eligible for the next stage of NID DAT 2024 admission process, the qualified candidates are required to submit their consent online (only). The process for submitting Online Consent starts somewhere around the last week of May 2024 and would last for about a week up to June 2024. The merit list is updated continuously happens during that time on the basis of online consent submitted by the qualified candidates.

Online Uploading of the Documents

For the purpose of verification, the qualifying candidates, as per the first Merit List, would be required to upload scanned copies of requisite documents. All the relevant documents must be issued in the name of the qualifying candidate. The scanned copies of original documents should be strictly in JPEG format only.

Uploaded documents are verified from the information entered in the [NID DAT 2024 Application Form](#) and any discrepancy would lead to the cancellation of candidature. Below is the list of relevant documents for which scanned copies have to be uploaded by the qualified candidates for B.Des. and M.Des. Programs (for all categories):

- Class 10 Marksheet
- Class 12 Marksheet
- Date of Birth Certificate
- Degree Marksheet (for admission to M. Des.)

OBC NCL/SC/ST category candidates have to submit valid category certificates which should be issued by appropriate competent authorities in addition to the above.

The scanned copies of the first and last page of the Passport and of the Equivalence certificate should be uploaded by the Overseas category candidates (both B.Des.or M.Des programs), in addition to the ones mentioned.
