- In Category-1, you cannot change the mentioned details but can send the request of change with supporting documents to the authority.
- You must send a proper mail, addressing the fields needs to be modified from your registered email ID.
- However, the Category-2 changes can be changed directly by logging into the official website of TS PGECET 2024, pgecet.tsche.ac.in.

Important Points for Category 1:

- Convener, TS PGCET Email ID – convener.appgect2024@gmail.com
- All the details and documents are to be sent from the registered email ID of the candidate.
- Correction in TS PGCET Application Form is done after the verification of the valid documents and approval by the Committee.
- In case, the Committee rejects the correction, the application is considered incomplete/ invalid.

TS PGECET 2024 Form Correction

Applicants could make changes in their filled application form. The correction window will remain open for two days. The entire procedure is done via online mode only. Osmania University does consider the request made for corrections after the due date under any circumstances.

Steps for TS PGECET 2024 Application Form Correction

- Step 1 – Visit the official portal of TS PGECET 2024
- Step 2 – Click on “Request Changes in Application Form” link.
- Step 3 – Enter TS PGECET 2024 Payment Reference ID, Registration Number, Qualifying Examination Hall Ticket No, Mobile Number & DOB.
- Step 4 – Click on the ‘Proceed’ button.
- Step 5 – Make the changes wherever required and save them.

Things to Remember for TS PGECET 2024 Form Correction

- Review all the information provided before submitting the form.
- All the fields need to be filled by the candidates.
- Make sure to fill in the same information as they have provided in the Application form of TS PGECET 2024.
- Upload the TS PGECET Mandatory Documents as per the specification prescribed by the officials.

Note: Candidates will not further be allowed to make corrections/modifications after the window is closed. And this process is a one-time opportunity to edit the application form.
