## **IMPORTANT NOTE**

- In case of vacancies, second and third rounds of counselling on the basis of 10+2 PCM score, will be conducted on 19-Aug, 2021 and 31-Aug, 2021 respectively. Further, as and when JEE Main - 2021 final ranking will be declared, then the admissions for vacant seats (if any) in subsequent rounds (after third round of online counselling) will be done on the basis JEE Main - 2021 rank only.
- 2. Candidates can visit <a href="https://admission.thapar.edu/">https://admission.thapar.edu/</a> and login to their application dashboard to check their allotted branch with Login ID and

- password generated at the time of filling the application form. Click on "View Branch Allocation Status" after login to the dashboard.
- 3. Only the candidates who have been allocated a branch in first round of counselling, will be able to login to check the branch allocation status.
- 4. Candidates have been allocated the branch provisionally on the basis of his/her 10+2 PCM merit. To be eligible for admission, the candidate must fulfil the eligibility conditions mentioned in Prospectus 2021-22 available at <a href="https://www.admission.thapar.edu">www.admission.thapar.edu</a>.
- 5. 10+2 PCM score and JEE Main 2021 percentile as per the records available with the Institute will be visible in the application dashboard in the candidate's login. Any discrepancy in the same shall be reported immediately at <a href="mailto:admissions@thapar.edu">admissions@thapar.edu</a> with 10+2 scorecard, JEE Main 2021 scorecard and application number.
- 6. If a candidate has qualified for a branch as per the category wise cut-off displayed above and that branch was selected by the candidate in branch preference order in the application form but still he/she has not been allocated that branch, such candidates should report at <a href="mailto:admissions@thapar.edu">admissions@thapar.edu</a> with 10+2 scorecard, JEE Main 2021 scorecard and application number.
- 7. The tie at 10+2 PCM marks has been broken by overall percentile score of JEE Main February/March/April (conducted in July) 2021. Best of the three (JEE Main February 2021/March 2021/April (conducted in July)) overall percentile has been taken into account. In case of tie at overall percentile, the same has been broken by following order:
  - a. Candidates obtaining higher Percentile Score in Mathematics in the JEE Main considered for tie break.
  - b. Candidates obtaining higher Percentile Score in Physics in the JEE Main considered for tie break.
  - c. Candidates obtaining higher Percentile Score in Chemistry in the JEE Main considered for tie break.
  - d. Candidates with higher marks in English at 10+2.
  - e. Candidates older in age to be preferred.
- 8. The candidate must pay the requisite fees on or before 17-08-2021 to be eligible for next rounds of online counselling for upgradation of branch as per their branch preference order.
- 9. The candidate can deposit the fee from their application dashboard using Debit Card, Credit Card, Net Banking etc. Click on "Pay Admission Fee + Semester Fee" after login to application dashboard to make the fee payment.
- 10. After making the payment, candidate will see Withdrawal Branch Allotted option in their application dashboard. Candidate should use this option only if they want to withdraw their admission from TIET. Such candidates will not be considered for admission in further rounds of counselling. On opting for Withdrawal Branch Allotted option, the candidate will be asked for bank account details to initiate the fee refund process. Candidate himself/herself will be responsible for the details provided for refund process. Refund will be credited as per the refund policy available on the institute website within two months of raising the refund request.
